
At this time there are no known applications and/or proposals that would directly affect the property and are pending governmental approval.

The Southwest Washington Regional Airport (airport) is planning a full reconstruction of the General Aviation apron and taxilane, along with a 75' x 40' reconstruction of Taxiway A and drainage pipe replacement due to settling. The project will include drainage improvements to be installed at the edge of pavement in the infield. The project scope also includes application of pavement markings.

# **B. Environmental Elements**

# 1. Earth Find help answering earth questions

## a. General description of the site:

The project area is located inside the airport fence southwest of the Fixed Based Operator (FBO) hangar. The proposed pavement reconstruction includes the general aviation apron adjacent to the FBO hangar, the taxilane serving the apron, and a portion of Taxiway A just south of the taxilane where a failed drainage pipe has caused settling. The existing apron, taxilane, and Taxiway A consist of asphalt pavement that is cracking and raveling and in need of reconstruction. There are grass infields adjacent to the apron/taxilane area which collect the stormwater runoff from the pavement.

## b. What is the steepest slope on the site (approximate percent slope)?

The site is flat, with slopes not exceeding approximately 2%.

c. What general types of soils are found on the site (for example, clay, sand, gravel, peat, muck)? If you know the classification of agricultural soils, specify them, and note any agricultural land of long-term commercial significance and whether the proposal results in removing any of these soils.

Three borings were done in the apron/taxilane area as part of the geotechnical investigation. The borings indicated asphalt thickness in the area varies from 2 inches to 7.25 inches. The asphalt overlies aggregate base with thickness varying from 6.75 inches to 12 inches. Below the existing pavement section, soils consist of silt to sandy silt or sand.

# d. Are there surface indications or history of unstable soils in the immediate vicinity? If so, describe.

There are no surface indications or history of unstable soils in the immediate vicinity.

# e. Describe the purpose, type, total area, and approximate quantities and total affected area of any filling, excavation, and grading proposed. Indicate source of fill.

The pavement demolition will include 1,700 SY of asphalt concrete pavement removal, 665 CY of excavation, and 116 CY of fill using existing excavated material. Reconstruction of the apron and taxilane will include import and placing of 900 CY of granular base material and 50 CY of topsoil. The grading area outside the pavement replacement is approximately 11,000 SF. The source of the granular base material and topsoil are unknown at this time.

f. Could erosion occur because of clearing, construction, or use? If so, generally describe.

No erosion is expected to occur because of clearing or construction. The project site if flat and BMP measures will be used to contain stormwater runoff. Airborne loess during summer months may be present during hot and windy days.

# g. About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt or buildings)?

The total area of the airport property is 114.62 acres. The area of existing impervious surfaces on the airport is approximately 35 acres or 30.54%. This project will add 1,445 square feet of impervious surface resulting in a new impervious surface coverage of 30.56%.

h. Proposed measures to reduce or control erosion, or other impacts to the earth, if any. During construction, BMPs will be implemented including temporary inlet protection and straw wattles.

Emissions from heavy machinery such as excavators, bulldozers, dump-trucks, generators during their use. Approximate quantities are unknown.

Currently no known source.

None. The contractor will be required to meet federal, state and local emissions regulations.

The Cowlitz River flows to the south about one-quarter mile west of the airport to its confluence with the Columbia River. The Coweeman River is approximately half a mile east of the airport, and flows south, joining the Cowlitz River just north of its confluence with the Columbia River.

There are no activities in the proposed scope-of-work that are within 200' of either river.

Total proposed surface areas do not exceed amounts that would trigger detention facilities. Stormwater from surface runoff within the project area will be collected in catch basins in the grassed infields and routed to the existing airfield drainage conveyance system.

No, only stormwater runoff will be collected in the storm system.

No, the current drainage patterns will not be altered.
